Assumed risks and due care to mitigate:

1. Tripping/falling along the edges and/or ditches of the greens and/or on equipment related to playing the sport of lawn bowls; the host club is expected to follow safety practices and to carry liability insurance.
2. Physical harm or exertion/health concern due to weather conditions beyond anyone's control; Bowls Alberta and Bowls Canada Boulingrin has Player Safety Policies that they adhere to for the protection of the players.
3. Illness due to food served at the host club; the host club is expected to meet health standards in handling and serving food.
4. Physical or mental harm from words or actions from other players and from the team coach or the team manager; all youth participating in the event must sign a *Code of Conduct and Ethics* form and those who coach the youth must have a *Vulnerable Sector Check (VSC)* and hold an up-to-date *Respect in Sport – Activity Leader Certificate* as well.

Assumption of Risk

I understand and accept the risks of the sport of lawn bowls and understand and accept the responsibilities of my child, of the host club and of Bowls Alberta to ensure a safe environment for the provincial event. I agree to provide supervision for competing in a provincial event if my child is younger than 18 years of age.

The key responsibilities related to Alberta's youth participation in the Canadian Youth

For the winner and runner-up of the applicable Alberta Youth tournament, or any player requesting support if the applicable AB (Alberta) Youth Tournament was not held, **BA will**,

- Provide coach support at the Canadian Youth Championships;
- Register the player with Bowls Canada Bowlingrin for the Canadian Youth Championships before the deadline
- Send player registration fee to Bowls Canada;
- Provide financial support according to the Player Support Policy
- Provide the youth player two provincial team shirts
- Provide the medalists attending the Canadian Championship with a BA Hoodie if they haven't received one in the last 2 years.

Parent/legal guardian of youth under 18 agrees to,

- Ensure they are aware of and comfortable with the supervision for the AB team;
- Book and pay for travel and accommodation
- Provide Health Card information and a *Medical Emergency Permission* form and their contact information for their youth attending the Canadian Youth Championships to the Coach;
- Inform Bowls Alberta office who will be accompanying the youth to the Canadian Championship;
- Complete the player 'service request'/meal form and submit to BCB, if wanted;
- Fill out these forms:
 - Youth Participation and Commitment,*
 - Youth Participation Agreement and Understanding*
- Review the *Athlete Code of Conduct and Ethics* and have the youth agree to abide by it;
- Contact the BA office with any questions
