

## Bowls Alberta & its Member Clubs Safe Sport Complaint Submission Information & Forms

Bowls Alberta and its member clubs are committed to ensuring that all participants can enjoy the sport of lawn bowls in a safe and inclusive environment that is free of abuse, harassment, and discrimination.

We acknowledge that creating a safe environment is a shared responsibility of each individual member in all our lawn bowls communities. For related concerns during Bowls Alberta's and/or club events/activities, please complete the following form to the best of your ability and submit to the Provincial Safe Sport Officer at: <a href="mailto:sso@bowlsalberta.com">sso@bowlsalberta.com</a> or to the Club's Safe Sport Officer if the incident was only club related and not at a Bowls Alberta sanctioned event.

An individual who files a complaint has the following responsibilities:

- To consider if the complaint/dispute can be dealt with using the Dispute Resolution Policy first of all, but if not or other concerns exist, continue with the formal complaint process.
- To report the incident(s) as soon as possible, especially if their safety and/or the safety of others is at risk immediately or at future events/activities;
- To provide as much detail as possible about the alleged conduct or incident, including the date, time, and location of the indiecent(s), the name of the person alleged to have engaged in the misconduct, details of what happened and/or what was said, names of any witnesses, description of action taken (if any), and copies of any documents that may be relevant, e.g., a letter, email, or note that pertains to any matter in issues;
- To cooperate fully in the investigation and resolution of any concerns, incidents, and complaints;
- To uphold the strict confidentiality of all individuals involved in the matter; most importantly
  to not discuss the incident further with anyone and request others that may be aware of the
  situation do so as well;
- To refrain from knowingly submitting a false, malicious, or vexatious report of misconduct or complaint to Bowls Alberta's Safe Sport Officer.

The following forms may be used to complete and submit one's complaint but an email or letter outlining the details of the incident as stated above is also sufficient to begin the process. Note there are two forms, one to use if the incident involved a minor (under 18 or under 25 for person with cognitive impairments) and could involve a concern and/or a complaint and a general one for a complaint against an adult.
